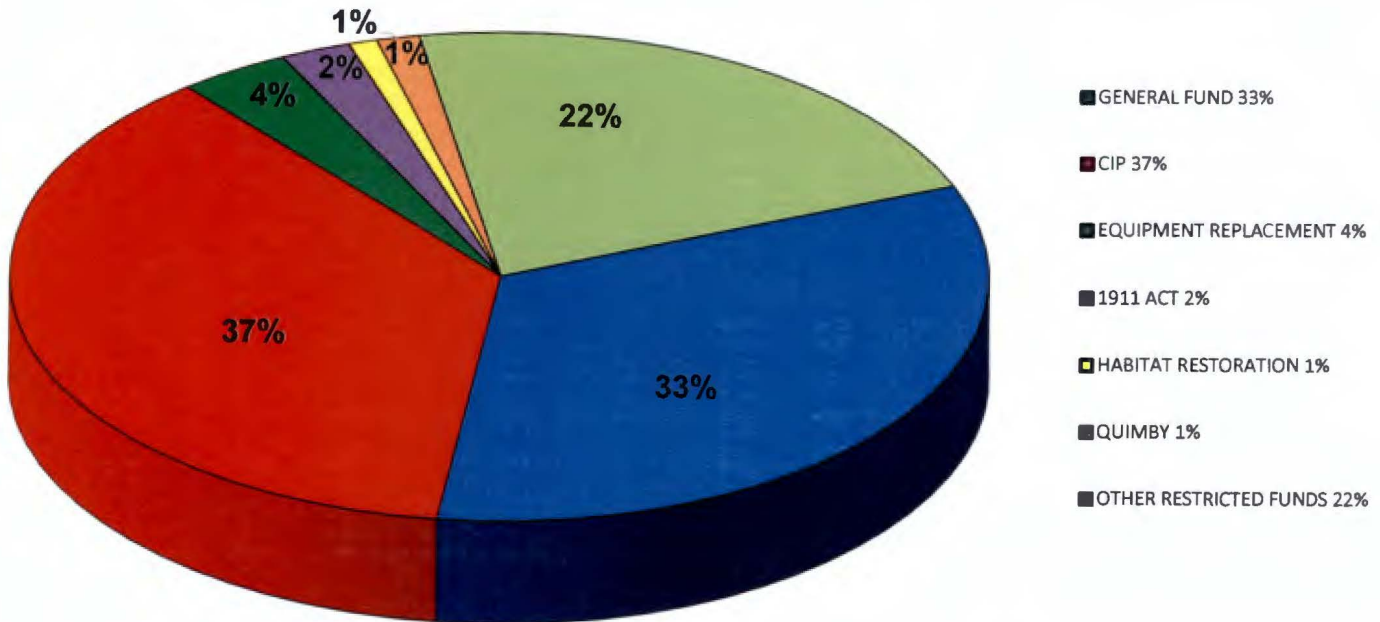

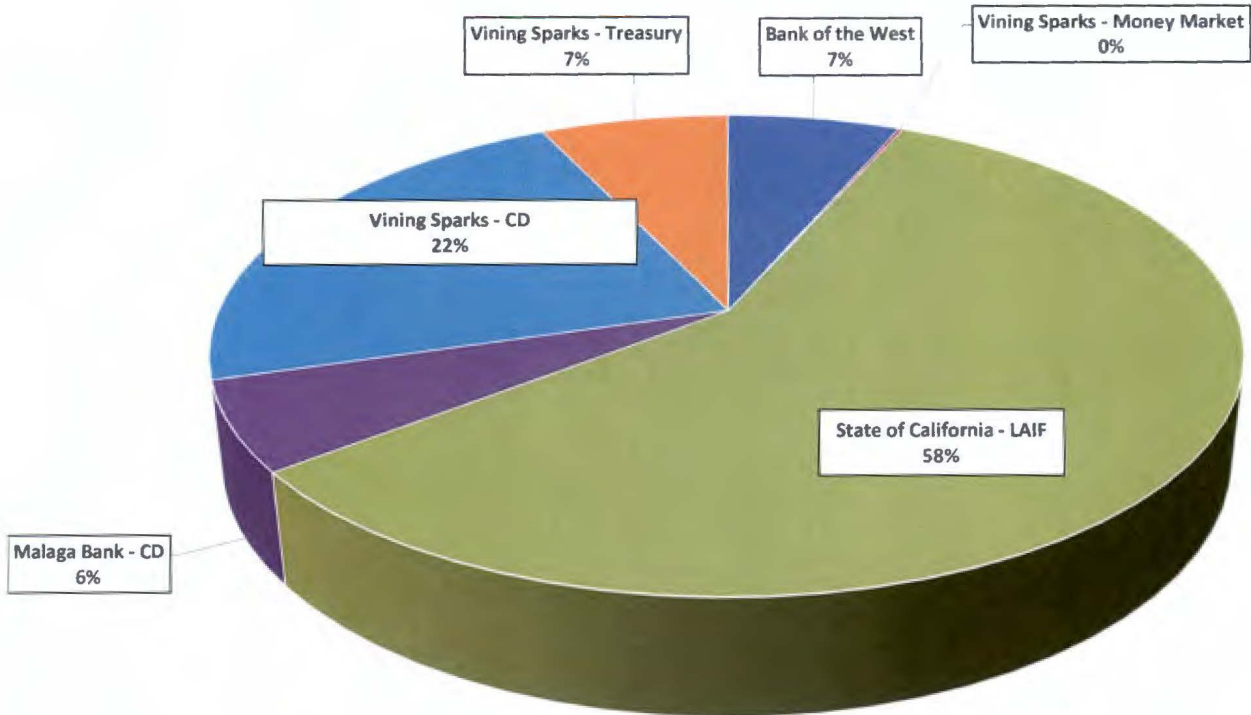

JUNE 2021

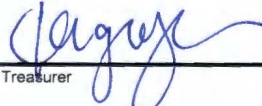
