Planning Commission Recruitment

The City of Rancho Palos Verdes is accepting applications for four vacancies on the Planning Commission, which considers land use applications and advises the City Council on zoning and development matters. Applications are due on October 22 by 4:30 p.m.

The seven-member Planning Commission makes decisions on specific private land use planning applications such as subdivision maps, variances, and conditional use permits; reviews environmental assessments, such as Environmental Impact Reports and Negative Declarations; makes decisions on development projects, zoning changes, grading, and neighborhood compatibility applications, view restoration permits, utility projects and right-of-way encroachments in the City; considers appeals of staff decisions on land use planning applications, and considers wireless telecommunication permit applications in the public right-of-way. The Planning Commission holds evening meetings at 7:00 p.m. on the 2nd and 4th Tuesday of each month, unless a special meeting is scheduled.

Vaccination Verification Requirements Begin in an Effort to Limit Virus Spread, Business Toolkit Now Available

Multiple vaccination verification requirements now affect L.A. County residents and workers. As of September 20, proof of COVID-19 vaccination status or a negative test result at indoor events in L.A. County with more than 1,000 attendees is required. September 30 was the deadline for healthcare and homecare workers across L.A. County to be fully vaccinated, while L.A. County employees had until October 1 and L.A. City employees have until today, October 5.

On October 7, proof of full vaccination or a negative test result will be required to enter outdoor mega events, and proof of at least one dose of the vaccine will be required to enter or work in indoor portions of bars, lounges, nightclubs, breweries, wineries, and distilleries in L.A. County. On November 4, bars and similar establishments throughout L.A. County will be required to verify full vaccination of all patrons and employees prior to entry to indoor portions of their establishments. To help businesses through all

California Becomes First State in Nation to Announce COVID-19 Vaccine Requirements for Schools

Late last week, Governor Gavin Newsom announced that [California will add the COVID-19 vaccine](#) to the list of vaccinations required to attend school in-person when the vaccine receives full approval from the Food and Drug Administration (FDA) for middle and high school grades, making California the first state in the nation to announce such a measure.

Students will be required to be vaccinated for in person learning starting the term following FDA full approval of the vaccine for their grade span (7-12 and K-6).

Based on current projections for full approval for ages 12+, the state anticipates the requirement would apply to grades 7-12 starting on July 1, 2022. Students who are under the age of full approval but within the grade span will be required to be vaccinated once they reach the age of full approval (with a reasonable period of time to receive both doses), consistent with existing procedures for other vaccines.

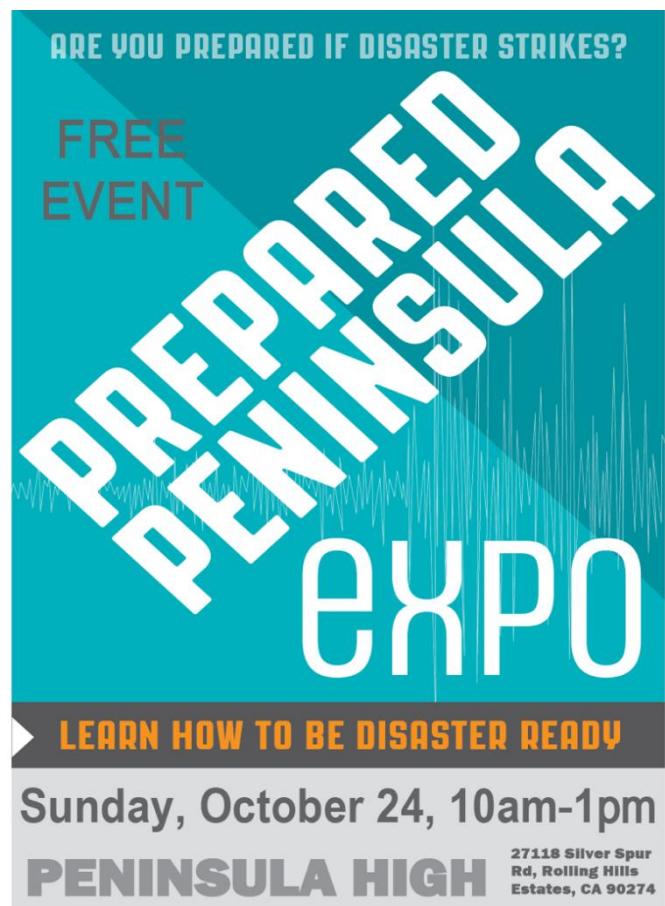

Seventh Annual Prepared Peninsula Expo – October 24

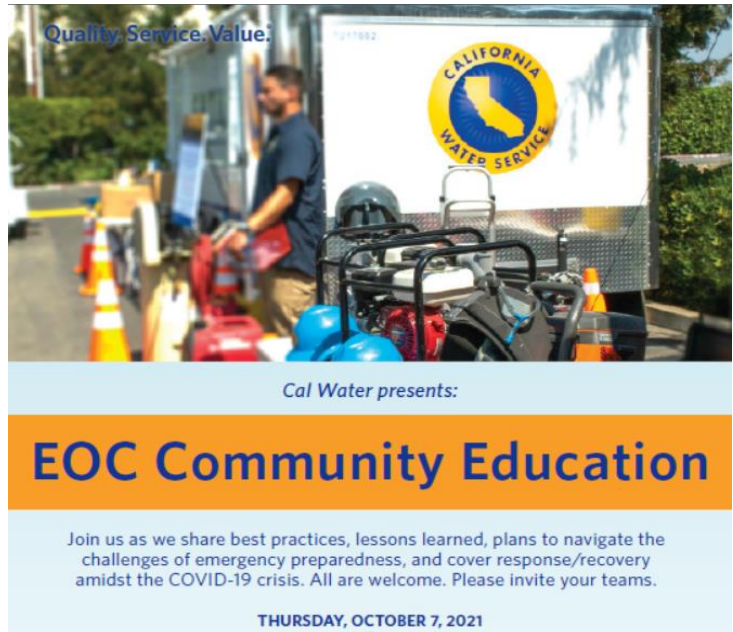
The four cities of the Palos Verdes Peninsula are once again teaming up to educate residents and the broader community on emergency preparedness at the 7th Annual Prepared Peninsula Expo on Sunday, October 24, from 10 a.m. to 1 p.m. at the Palos Verdes Peninsula High School, 27118 Silver Spur Rd, Rolling Hills Estates, CA 90274. The Prepared Peninsula Expo is an annual event the Peninsula Cities produce to help the Palos Verdes Peninsula residents learn to mitigate, prepare, respond, and recover should a disaster strike. This free event will teach you how to protect yourselves, your family, and your pets in a disaster.



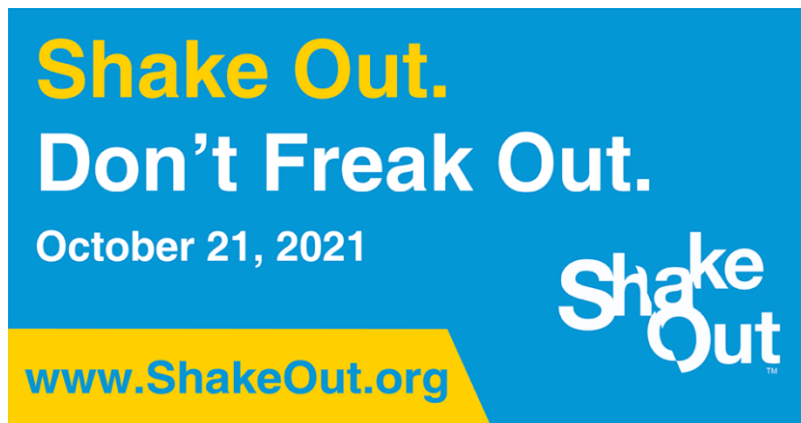
This information-filled expo will provide a free lunch (while supplies last) and feature dozens of exhibitors, demonstrations, and equipment displays. Exhibitors include local organizations giving tips and tools and retail vendors selling preparedness goods, like extended life water, emergency bags, meals-ready-to-eat (MREs), and more. The Prepared Peninsula Expo is a great opportunity to learn from experts in emergency readiness about how to prepare your family and safeguard your home for the event of an earthquake, wildfire, or other disasters.

Cal Water Virtual EOC Training

On October 7, 2021, City Staff will attend a virtual Emergency Operations Center (EOC) Community Education Presentation hosted by Cal Water representatives to improve regional coordination among key public safety agencies in the event of a large-scale emergency or disaster. Chief Al Terrell, Cal Water's Director of Safety, Emergency Response, and Physical Security will moderate the October 7th meeting.



During this meeting, participants will have the opportunity to share best practices, lessons learned, and strategies for navigating the difficulties associated with emergency preparedness, response, and recovery in the aftermath of the COVID-19 crisis and wildfires this year. This training is an excellent opportunity for City staff, representatives from local agencies, and Cal Water to build relationships so that, in the event of an emergency or disaster, these representatives can work more effectively together to serve community members.



Drop, Cover and Hold On for the Great ShakeOut on 10/21 at 10:21 a.m.

With 330 million people living and working in the United States, a major earthquake could cause unprecedented devastation. While some parts of California are more vulnerable to earthquakes than others, the entire state is at a higher risk than the rest of

the country. You could be anywhere when an earthquake strikes: at home, at work, at school, or even on vacation. The key to surviving an earthquake and reducing your risk of injury lies in planning, preparing, and practicing what you and your loved ones will do if it happens.

International ShakeOut Day, observed annually on the third Thursday of October, is a day of individual and community events culminating in the world's largest earthquake drill. International ShakeOut Day is intended to inspire others to prepare for large earthquakes and to prevent disasters from becoming catastrophes. What we do now, in the lead-up to the next major earthquake, will determine our ability to survive and recover. International ShakeOut Day will take place on October 21 this year.

Take part in this year's Great ShakeOut worldwide earthquake drill on Thursday, October 21 at 10:21 a.m. by practicing how to "Drop, Cover, and Hold On" in the event of an earthquake.



The 2021 ShakeOut drill will be the largest preparedness event in history. Registered participants will receive instructions on how to plan their drill and involve others

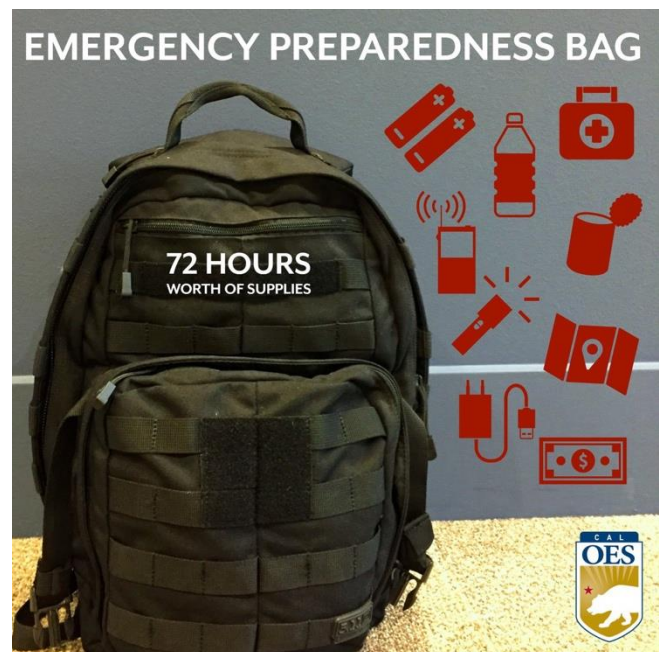

Disasters Don't Plan Ahead - You Can

Disaster can happen at any time, often with little to no warning. The widespread devastation caused by a catastrophic disaster has the potential to cut you off from the rest of the world for several days. Following a disaster, emergency rescuers will arrive on the scene as soon as possible to assist you, but it may take some time for them to reach you. The time to start thinking about what to do in an emergency is before it happens. By following some simple guidelines, you can help prepare your family, neighborhood, business or school to be better prepared and self-sufficient after the next disaster.



- ⇒ **HAVE A PLAN:** A good place to begin emergency preparedness is by writing a Family Emergency Plan. Your Plan should include every member of your household including pets.
 - Your family may not be together if a disaster strikes, so it is important to talk to your friends and family about how you will communicate before, during, and after a disaster.
 - Be sure to establish a family meeting place that's familiar and easy to find.
- ⇒ **KEEP SUPPLIES:** A Disaster Supply Kit is any pre-assembled group of items that will improve the health and safety of your family during a disaster. Gather supplies that will last for several days after a disaster for everyone living in your home. Download an emergency supply list at ready.gov/kit to get started on your kit. **#BeReady #BuildAKit**

- ⇒ **BE INFORMED:** It is important to Know what disasters and hazards could affect your area, how to get emergency alerts, and where you would go if you and your family need to evacuate. Make sure your family has a plan and practices it often.
- Learn about natural hazards that may affect the City by reading our recently adopted and FEMA approved [Local Hazard Mitigation Plan](#).
 - **Register for emergency notifications from Alert SouthBay:** Alert Southbay is the City's primary vehicle for emergency communications. Users can Sign up for Alert SouthBay emergency alerts by texting "alertsb" to 888-777
 - Be sure to stay connected and get updates from the City by following RPV on [Nextdoor](#), [Facebook](#), [Twitter](#) and [Instagram](#).
- **Have your Ready! Set! Go! Wildfire Action Plan in place:** It is critical for residents to be familiar with the Ready! Set! Go! program that provides important preplanning and evacuation information. To download the Ready! Set! Go! Wildfire Action Plan and view informational how-to videos, visit fire.lacounty.gov/rsg

Thunderstorms & Lightning Safety

Thunderstorms last an average of 30 minutes and can cause dangerous lightning, large hail, flash flooding, and strong winds. They often develop quickly, and with little warning, it is important to learn the danger signs and plan ahead. Lightning is a leading cause of injury and death from weather-related hazards.

Although most lightning victims survive, people struck by lightning often report a variety of long-term, debilitating symptoms.

Understanding Severe Weather Alerts:

The National Weather Service issues severe thunderstorm watches and warnings to alert the public of potential severe weather. It is important to understand the difference between watch and warning, so you know what to do to stay safe:

- **Severe Thunderstorm Watch: Be Prepared!** Severe thunderstorms are possible in and near the watch area. Stay informed and be ready to act if a severe thunderstorm warning is issued. The watch area is typically large, covering numerous counties or even states.



- **Severe Thunderstorm Warning: Take Action!** Severe weather has been reported by spotters or indicated by radar. Warnings indicate imminent danger to life and property. Take shelter in a substantial building. Warnings typically encompass a much smaller area (around the size of a city or small county) that may be impacted by a large hail or damaging wind identified by an NWS forecaster on radar or by a trained spotter/law enforcement who is watching the storm.

□ **HOW TO STAY SAFE BEFORE A THUNDERSTORM THREATENS:**

- **PREPARE NOW:** In advance of any storm, be sure your property is secure. Make a list of items outside your home you will need to tie down or put away so that they don't blow away or fly through a window.
- **Be Weather-Ready:** Check the forecast regularly to see if you're at risk for severe weather. Listen to local news or a NOAA Weather Radio to stay informed about severe thunderstorm watches and warnings.
- **Prepare Your Home:** Keep trees and branches trimmed near your house. If you have time before severe weather hits, secure loose objects, close windows, and doors, and move any valuable objects inside or under a sturdy structure.
- **Make a Kit:** Gather supplies that will last for several days after a disaster for everyone living in your home. Don't forget to consider the unique needs each person or pet may have in case you have to evacuate quickly. Update your kits and supplies based on recommendations by the Centers for Disease Control.
- **Create a Communications Plan:** Have a family plan that includes an emergency meeting place and related information. Additional information for creating a communications plan is available at: <http://ready.gov/make-a-plan>
- **Practice Your Plan:** Conduct a family severe thunderstorm drill regularly, so everyone knows what to do if a damaging wind or large hail is approaching. Make sure all members of your family know to go there when severe thunderstorm warnings are issued.

□ **HOW TO STAY SAFE DURING A THUNDERSTORM:**

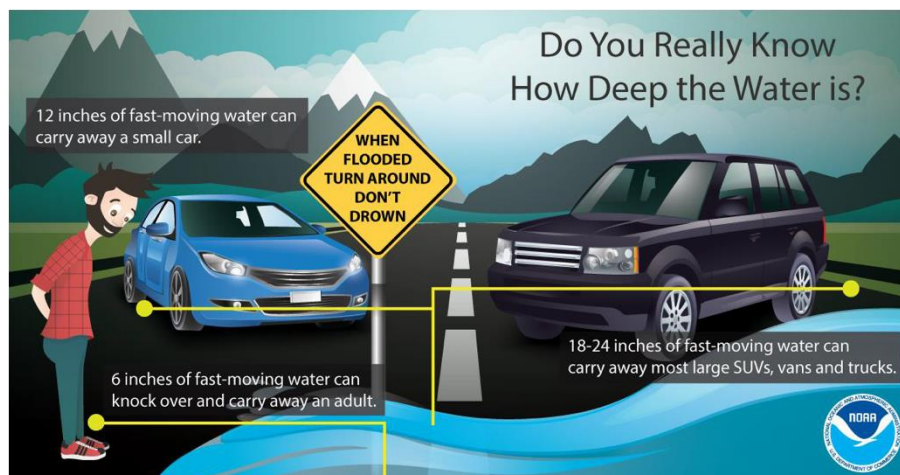
- **Stay Weather Ready:** Continue to listen to local news or a NOAA Weather Radio to stay updated about severe thunderstorm watches and warnings.
- **If You Are Outside:**
 - **When thunder roars, go indoors:** Immediately go inside a sturdy building when severe thunderstorms are approaching and move to

an interior room or basement. Take your pets with you if time allows. Take shelter in your car if you are not near a sturdy building.

- If you are in an open area, go to a low place such as a ravine or valley and watch out for flash flooding.
- If you are in a forest, seek shelter in a low area under growth of small trees.
- If you are boating or swimming, get to land and seek shelter immediately.

○ **If You Are in a Car:**

- Being in a vehicle during severe thunderstorms is safer than being outside; if caught in a vehicle during a severe thunderstorm Safely exit the roadway and park if possible. Stay in the vehicle and turn on the emergency flashers until the heavy rain ends. Avoid touching metal or other surfaces that conduct electricity in and outside the vehicle.
- **Turn Around. Don't Drown!** Just six inches of fast-moving water can knock you down, and one foot of moving water can sweep your vehicle away. Each year, more deaths occur due to flooding than from any other thunderstorm related hazard. People underestimate the force and power of water. Many of the deaths occur in cars swept downstream. It is NEVER safe to drive or walk into flood waters.



○ **If You Are Inside a Building**

- Stay away from windows and doors. Strong thunderstorms can cause flying debris that could do significant damage.

- Avoid using a corded telephone, except for emergencies. Cordless or cellular telephones are safe to use. Unplug appliances, air conditioners, and other electrical items like computers to avoid damage from a power surge.
- Avoid showering, bathing, washing dishes, or doing laundry. Plumbing and bathroom fixtures can conduct electricity.
- Avoid contact with metal objects (yard equipment, motorcycles, bicycles, etc.).
- Stay inside until at least 30 minutes after you last hear thunder or see lightning.

□ HOW TO STAY SAFE AFTER A THUNDERSTORM:

- **Stay Informed:** Continue listening to local news or a NOAA Weather Radio to stay updated about severe thunderstorm watches and warnings. More severe thunderstorms could be headed your way.
- **Contact Your Family and Loved Ones:** Let your family and close friends know that you're okay, so they can help spread the word. Text messages or social media are more reliable forms of communication than phone calls.
- **Assess the Damage:** After you are sure the severe weather threat has ended, check your property for damages. When walking through storm damage, wear long pants, a long-sleeved shirt, and sturdy shoes. Contact local authorities if you see power lines down.
- **Help Your Neighbor:** If you come across people that are injured and you are properly trained, if needed, provide first aid to victims until emergency response team members arrive.

Weekly Crime Report Summaries

The Lomita Sheriff's Station provides weekly crime report summaries for the City of Rancho Palos Verdes. From September 19-25, there were nine reported crimes in the City of Rancho Palos Verdes: five grand thefts of catalytic converters, two petty thefts, one residential burglary, and one assault.

October is National Pedestrian Safety Month

This October, the National Highway Traffic Safety Administration (NHTSA) launched the first National Pedestrian Safety Month with the goal of increasing awareness about pedestrian safety and reminding drivers and walkers that staying safe is a shared responsibility.

5 Walking Safety Tips:

1. Walk on sidewalks whenever they are available. If one isn't available, walk facing traffic and as far from traffic as possible.
2. Keep alert at all times; don't be distracted by electronic devices that take your eyes (and/or ears) off the road.
3. Whenever possible, cross streets at crosswalks or intersections, where drivers expect pedestrians, and look for cars in all directions, including those turning. Wait for a gap in traffic that allows enough time to cross safely, and watch for traffic as you cross.
4. Be visible at all times. Wear bright clothing during the day and wear reflective materials or use a flashlight at night. Never assume a driver sees you. Make eye contact with drivers as they approach to make sure you are seen.
5. Watch for cars entering or exiting driveways or backing up in parking lots.

Tips to Prevent Vehicle Burglaries

Take steps today to prevent thefts from your vehicle. Residents are strongly encouraged to use “Lock It or Lose It” prevention tips every day. It only takes a matter of seconds for a thief to break into your car and grab your valuable items.

Look through the windows of your vehicle. What do you see? A bag on the passenger seat? A charging cord? A garage door opener? Change in a cup holder? Take it with you or remove it from plain view and be sure to close all windows and lock doors.



Follow these tips to help prevent vehicle burglaries:

1. Remove all valuable items from your car including purses and electronics.
2. If you must leave valuables behind, put them in your trunk or locked glovebox before you reach your destination. Avoid doing so while in plain view.
3. Close all windows and lock your doors.
4. Park in a locked garage or well-lit areas.

ABLE Accounts: A Valuable Financial Solution for People with Disabilities

[Achieving a Better Life Experience or ABLE accounts](#) are tax-advantaged savings accounts for individuals with disabilities and their families. These accounts help disabled people pay qualified disability-related expenses without affecting their eligibility for government assistance programs.

Here are some key things people should know about these accounts.



Annual contribution limit

- The 2021 limit is \$15,000.
- Certain employed ABLE account beneficiaries may make an additional contribution up to the lesser of these amounts:
 - The designated beneficiary's compensation for the tax year.
 - The poverty line for a one-person household. For 2021, this amount is \$12,880 in the continental U.S., \$16,090 in Alaska, and \$14,820 in Hawaii.

Saver's credit

- ABLE account designated beneficiaries may be eligible to claim the [saver's credit](#) for a percentage of their contributions.
- The beneficiary claims the credit on [Form 8880, Credit for Qualified Retirement Savings Contributions](#). The saver's credit is a non-refundable credit available to individuals who meet these three requirements:
 - Are at least 18 years old at the close of the taxable year
 - Are not a dependent or a full-time student
 - Meet the income requirements

Rollovers and transfers from section 529 plans

- Families may rollover funds from a 529 plan to another family member's ABLE account.
- The ABLE account must be for the same beneficiary as the 529 account or for a member of the same family as the 529 account holder. Rollovers from a section 529 plan count toward the annual contribution limit. For example, parents would meet the \$15,000 annual contribution limit by contributing \$10,000 to their child's ABLE account and rolling over \$5,000 from a 529 plan to the same ABLE account.

Qualified disability expenses

- States can offer ABLE accounts to help people who become disabled before age 26 or their families pay for disability-related expenses. These expenses include housing, education, transportation, health, prevention and wellness, employment training and support, assistive technology, and personal support services.
- Though contributions aren't deductible for federal tax purposes, distributions, including earnings, are tax-free to the beneficiary, if they are used to pay qualified disability expenses.

Southern California Edison Upcoming Project

Southern California Edison (SCE) will start a project involving covered conductor wires and equipment upgrades. These upgrades will be executed to increase protection from trees, animals, or balloons causing power outages and potentially starting fires, increase protection from power surges, and increase power capacity to the area. The work will include pole replacements and increasing wire sizes and equipment. The work will be completed along Palos Verdes Drive East, including but not limited to Bronco Drive, Stallion Road, Surrey Lane, Cayuse Lane, and Via El Miro. SCE anticipates the work to begin on October 15 and conclude on or around October 20. SCE has informed the affected residents in advance of this work.

New Traffic Signal at Intersection of Palos Verdes Drive South and Palos Verdes Drive East

Work continues this week for the new traffic signal project at the intersection of Palos Verdes Drive South and Palos Verdes Drive East, including boring for underground conduit and digging for signal pole foundations. Work will take place through the end of December from approximately 8:30 a.m. to 4:30 p.m. Monday through Friday, with regular partial eastbound and westbound bike lane closures around the intersection. Expect delays, proceed cautiously through the work zone, and follow all signs and instructions.



Next Paper/Document Shredding Event

The next paper/document shredding event is scheduled for Saturday, October 23, from 8 a.m. to 11 a.m. at City Hall/Civic Center in the overflow parking lot. More details on this event will be provided in the coming weeks.



Prepare for the Citywide Brush Clearing

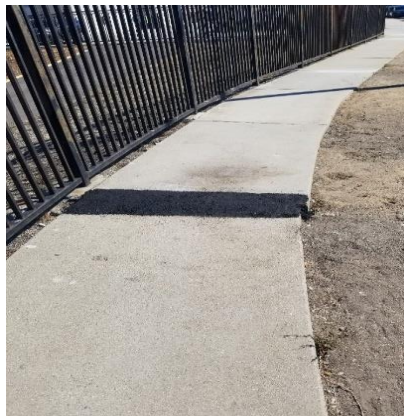

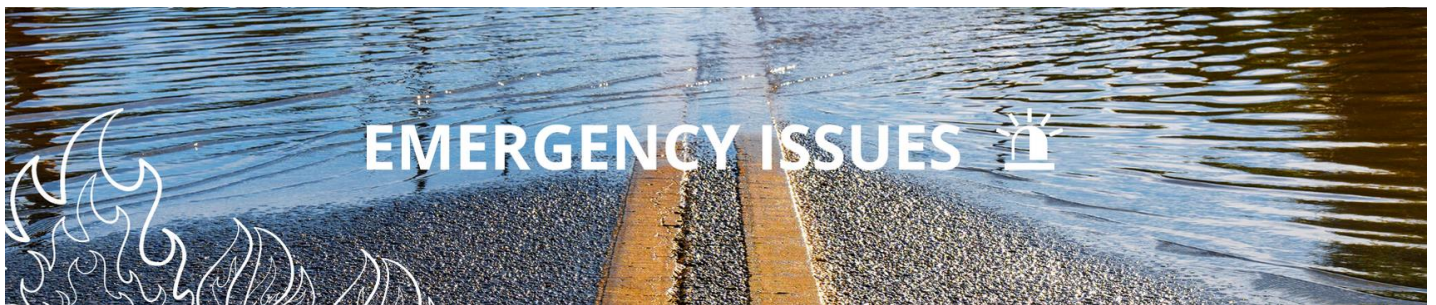

Mixed-Use Overlay Zoning District Kick-Off Meeting

On September 21, 2021, the City Council authorized retaining the services of Planning consultant, Dudek, to establish a potential mixed-use overlay zoning district within the City's Commercial, and some Institutional zoning districts. This is an effort as part of the Housing Element Update strategy to accommodate the 6th Cycle Regional Housing Needs Assessment (RHNA) allocation of 647 units (8 units carried over from the 5th Cycle) among various income categories. On September 30, 2021, City staff from the Planning Division, Public Works Department, and the City Manager's office participated in a kick-off meeting with Dudek and their subconsultants for community outreach and

economic analysis. The process will include opportunities for community engagement slated for next year with the goal of adopting an ordinance by Spring 2023. Planning Commission Forwards an Updated Sign Code to City Council



On Tuesday, September 28, 2021, staff presented the proposed draft Sign Code Ordinance to the Planning Commission for their consideration and approval on the consent calendar. This matter was continued from the September 14, 2021 meeting due to the comprehensive nature of the code amendment, which is proposed to completely replace the current Sign Permit section of the Municipal Code. At the September 14

meeting, the Planning Commission considered the proposed substantive development standards in the draft sign code and directed staff to bring back the updated sign code, which included their requested modifications to the draft ordinance, for approval on the consent agenda at the next meeting. At the September 28 meeting, the Planning Commission voted 6-0-1 (one Commissioner was absent) to approve Staff's recommendations and send the draft code to the City Council for approval, which is tentatively scheduled for November 2. Gabrieleño/Tongva Native American Memorial at Abalone Cove Park: October 16 Unveiling Date

Plans are underway to unveil a memorial honoring the Gabrieleño/Tongva San Gabriel Band of Mission Indians-the “First Peoples of the Los Angeles Basin.” This project dates back to 2016 when Tom Steers first approached the City with the idea for a memorial.



Tom has coordinated the funding of this project with private donations. The City is very excited to educate the public about the Gabrieleño/Tongva Native Americans and the important role they have played in the history of Southern California, specifically Rancho Palos Verdes. Gabrieleño/Tongva descendants have been closely involved in the design and artwork for the monument plaques to ensure their historical accuracy and appropriateness. The City is very appreciative of professional sculptor Geri Jimenez Gould for creating such a remarkable piece of artwork.

A monument unveiling event is scheduled for October 16 from 10 a.m. to 12 p.m. Chief Anthony 'Red Blood' Morales and tribal members will participate with blessings and songs in their regalia. Invitations were sent last week to elected officials. Additional details will be forthcoming.

City Council Update on ParkMobile Parking System and Related Preserve Parking Issues

On October 5, the City Council made changes to the ParkMobile parking reservation system and other Preserve parking-related issues. Below are the actions taken by City Council:

- (1) Received and filed an update on the implementation of the ParkMobile system;
- (2) Approved, if feasible, the following modifications to the ParkMobile parking system:
 - a) Allow same-day reservations (cutoff one hour prior to reservation start) with change to one-hour blocks of time at pro-rated amount if feasible and return in 90 days with an update.
 - b) Create simplified access to the ParkMobile reservation link
 - c) Improve instructional signs
 - d) Discontinue requiring reservations for Recreational Residential Parking Permit holders
 - e) Incorporate a QR code that directs people to the reservation page.
 - f) Direct staff to work with ParkMobile to improve efficiency and usability of system
- (3) Continue the parking moratorium on six parking spaces along Crenshaw Boulevard until December 21, 2021;
- (4) Received and filed an update on the ParkMobile Parking System's impacts to other trailheads and neighborhoods;
- (5) Received and filed an update on the City's search engine optimization and related efforts;
- (6) Sunsetting the Pilot Preserve Shuttle Program; and
- (7) Directed staff to return with an alternative Rattlesnake Trailhead Gate location

A further update on the ParkMobile parking system and Preserve parking issues is scheduled for December 21. A total of 105 ParkMobile reservations were made between September 27-October 3: 39 paid reservations, 34 resident reservations, and 32 free reservations on weekdays from 7:00 a.m. to 8:45 a.m. Staff will continue to report on total reservations and other data points each week.

City Council Reviews Preserve-Related Municipal Code Changes

On October 5, 2021, the City Council introduced Ordinance No. 650 to:

- Repeal and replace Chapter 12.16.020 to allow Class 1 e-bikes in the Preserve

- Repeal and replace Chapter 12.16.010 to strengthen regulations to protect public facilities from damage/vandalism
- Repeal and replace Chapter 12.16.045 to prevent flight of ultralight aircrafts (paragliders, parasails, etc.) over City property
- Add Chapter 12.16.170 to regulate vending, commercial services, and industrial activity in parks, preserve, beaches, and recreational facilities
- Rename Chapter 12.16 of the Municipal Code

Playground Equipment Surface Replacement Project

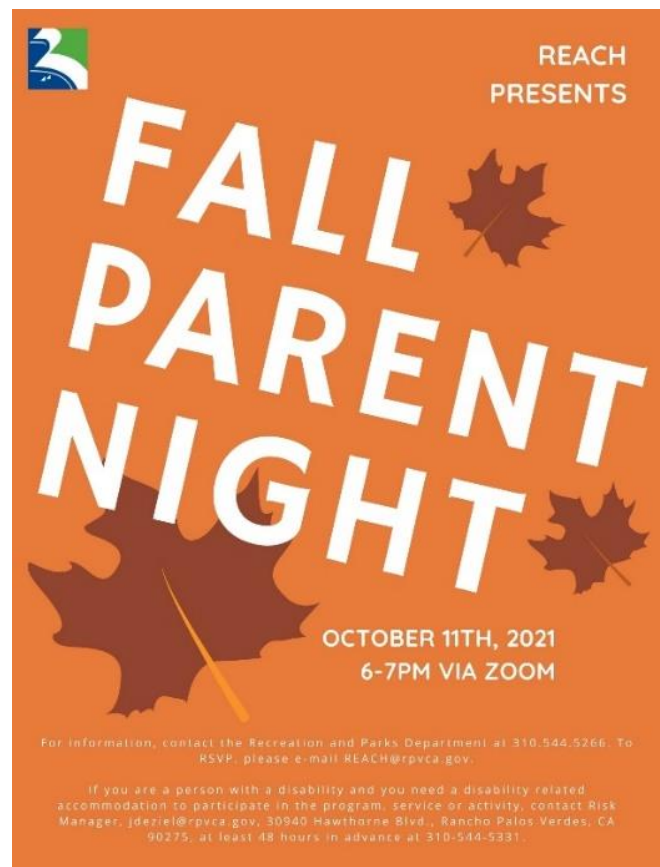

Abalone Cove Reserve, Park and Beach

From September 27 – October 3:

Forrestal Reserve/Adjacent Properties

OSM continues to patrol the park and trails to address reports of dogs off leash in the fields and unauthorized access. During this week, Rangers made contact with two vehicles driving recklessly at the upper parking lot. No other violations were observed.

On Friday, October 1, OSM staff installed a small retention wall to stabilize the trail and provide additional safety for trail users, and to ensure patrons stay on the trail.

Ocean Trails Reserve

Trail work on the Eastern section of Catalina Trail adjacent to Sagebrush Walk Trail was postponed to begin October 18 (initially marked for October 4). Contractors will be modifying the slope of the trail for better water drainage and replacing the steps for public safety. Trail closures will take place when crews are on site.

Portuguese Bend Reserve

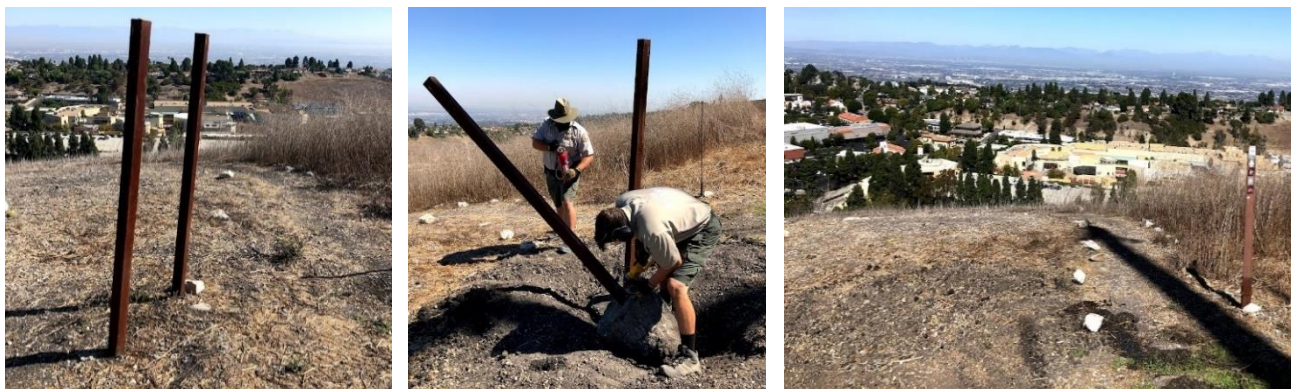
On October 2, water was reported on the trails, from a section of pipe adjacent to Rim Trail on Burma Road. CalWater was notified and shut off water. Crews were on site during the week of October 4 to make repairs. The leakage was caused by added pressure on the pipe from recent land movement. The section of trail will be closed while crews are on site.



Trail conditions as of Sunday morning, on October 3, and Monday evening, on October 4 as Cal Water replaced a section of the pipe to modify the hillside.

Vista del Norte Reserve

The remaining posts from the monument sign located at the upper Vista del Norte Trailhead have been removed. The monument sign had been damaged several months ago, and repairs were unsuccessful. The city is coordinating with the PVPLC for replacement.

OSM removed and discarded several collected mustard stalks, an empty glass marijuana jar, and several leis in the nearby vegetation. No lighter or other ignition source was found.



Parks and Trails Open

Beaches, parks, and trails, including the Palos Verdes Nature Preserve, are open. In accordance with the L.A. County and State of California Health Officer Orders, private, informal, outdoor gatherings outdoors are permitted. L.A. County continues to urge everyone, especially those who are not or cannot be vaccinated against COVID-19, to exercise caution and good judgment as physical distancing requirements and capacity limitations have lifted. In addition, all individuals must follow the requirements in the Guidance for the Use of Face Coverings issued by the L.A. County Department of Public Health.

When participating in gatherings or activities, all park rules must be followed, and attendance at informal gatherings cannot exceed thresholds in the Special Event Permits ordinance.

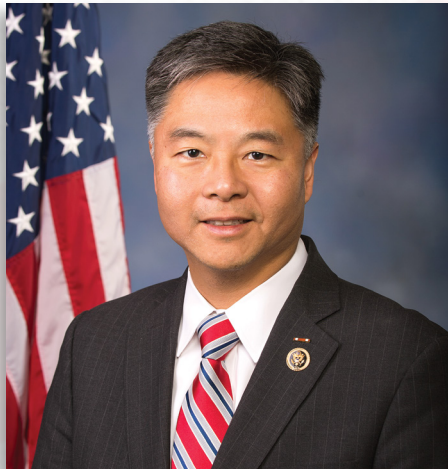
