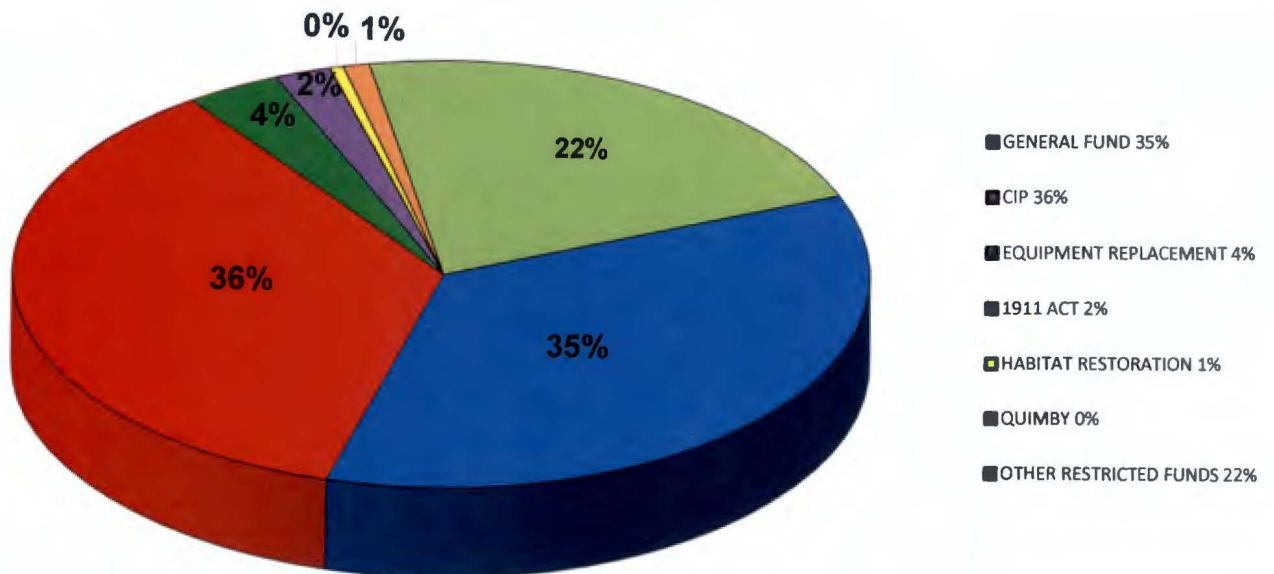

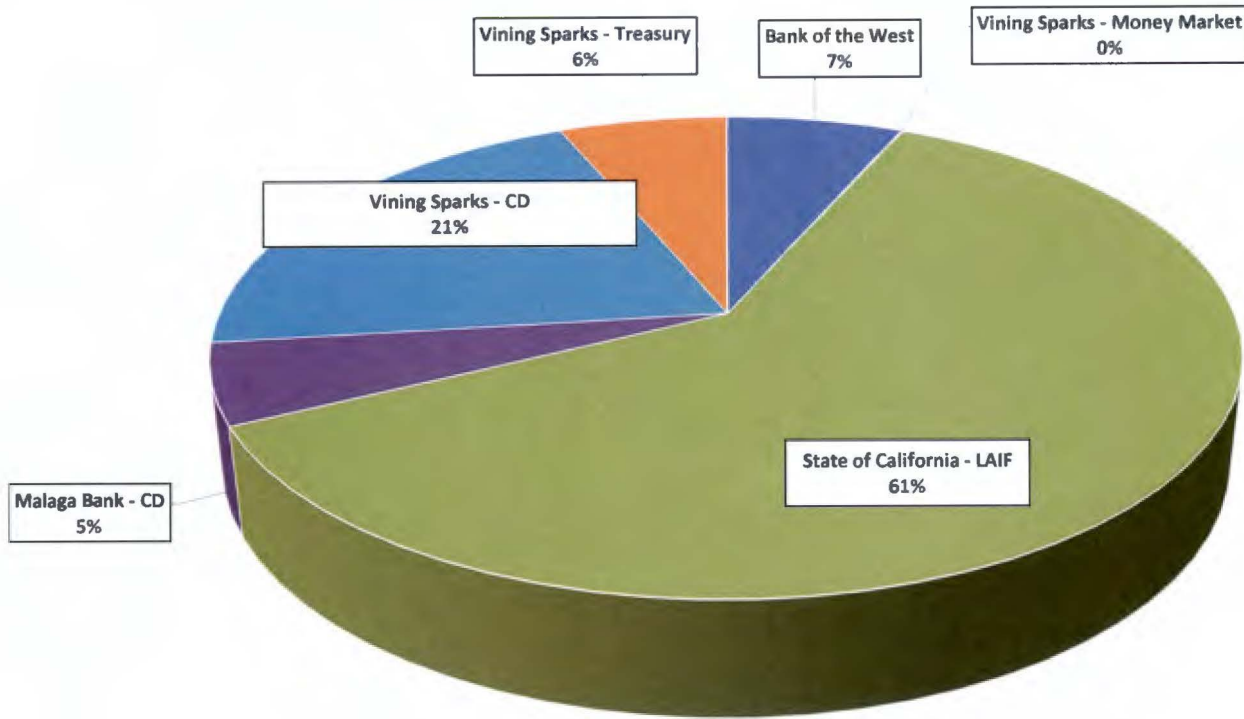

MARCH 2022

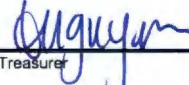
