NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on November 14, 2017 at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following:

**AFTER-THE-FACT VARIANCE & SITE PLAN REVIEW (CASE NO. ZON2017-00362):** A request to consider the following:

- Legalize the construction of a 614 square foot deck with planter boxes over the rear yard lower drainage swale;
- Legalize the construction of a 552 square foot deck with planter boxes over the rear yard mid-slope drainage swale;
- Construct a new 544 square foot deck with planter boxes over the rear yard upper drainage swale; and,
- Construct at-grade steps along the rear yard slope.

All three decks range in height between 12" to 30" from adjacent grade and are connected and accessible by the existing and proposed at-grade steps.

The Planning Commission's decision may then be appealed, in writing, to the City Council.
