Any written comments to be included in that Staff Memorandum needs to be submitted no later than **June 3, 2019**. Any correspondence submitted after June 3, 2019 will be considered as late correspondence and will be given to the Planning Commission on the night of the meeting. Written materials, including emails, submitted to the City are public records and may be posted on the City's website. In addition, City meetings are televised and are accessed through the City's website. Accordingly, you may wish to omit personal information from your oral presentation or written materials as it may become part of the public record regarding an agenda item.
