NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, December 14, 2021, at 7:00 PM. The meeting will take place remotely in accordance with Government Code Section 54953(e) et seq. (AB 361), and Resolution 2021-53 adopted by the City Council on October 19, 2021, and will be conducted through a *hybrid combination of in-person and/or all virtual attendance of the seven members of the Planning Commission and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PVPTv channels Cox 35 and Frontier FiberOptic 39. Public participation is highly encouraged using the virtual platform as there will be very limited seating (with a combined total of 25 people between two rooms) at Hesse Park. The Planning Commission will consider the following proposed project:

MAJOR GRADING PERMIT (CASE NO. PLSR2020-0239) – A request to allow the following improvements on a vacant lot:

- Conduct 2,445 cy³ of grading (2,425 yd³ of cut and 20 yd³ of fill with 2,405 yd³ of export) to accommodate a new 6,445 ft² single-family, split-story residence and ancillary site improvements.
