NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, July 12, 2022, at 7:00 p.m.

The meeting will take place in accordance with Government Code § 549539(e) et seq (AB 361) and pursuant to Resolution No. 2022-27, adopted by the City Council on May 17, 2022, and as renewed by subsequent resolution(s) thereafter. The regular meeting of the Planning Commission will be conducted through a hybrid combination of in-person and/or all virtual attendance of the Planning Commission and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PVPtv channels Cox 35 and Frontier FiOS 39. The Planning Commission will consider the following proposed project:

Conditional Use Permit (CASE NO. PLCU2021-0003) – A request to approve a new Conditional Use Permit (CUP) to allow the continued operation of an existing Verizon Wireless telecommunications facility located on an existing 62-foot tall monopole and in a ground-level enclosure on a California Water Service (Cal-Water) reservoir site.

LOCATION: **3960 Crest Road**

PROPERTY OWNER: **California Water Service**

APPLICANT: **Verizon Wireless/ATC Sequoia LLC (Eduardo Galdamez, CORE Development Services/Butler America)**
