NOTICE IS HEREBY GIVEN that the Director of Community Development of the City of Rancho Palos Verdes will consider the following project request pursuant to Council-adopted Condition No. 2a(6) of Resolution No. 2021-66:

**GRADING PERMIT (CASE NO. PLGR2022-0030)** – A request to conduct grading activities for the installation of lawn crypts in Area 2 of the Green Hills Memorial Park Masterplan including 580.8 yd<sup>3</sup> of balanced grading in the Alta Vista Gardens section of the Masterplan, consisting of 290.4 yd<sup>3</sup> cut and 290.4 yd<sup>3</sup> fill; and 264 yd<sup>3</sup> of balanced grading in the Inspiration Slope section of the Masterplan, consisting 132 yd<sup>3</sup> cut and 132 yd<sup>3</sup> fill, as outlined in the aerial and project maps included in this notice . The project also proposes to construct ancillary 3 foot-high walls and benches adjacent to family estate areas and walkways.

This proposed project is within the scope of the Planning Commission-approved Mitigated Negative Declaration (Environmental Assessment for Case No. ZON2003-00086) and subsequent addendums for the Green Hills Cemetery Master Use Plan.
