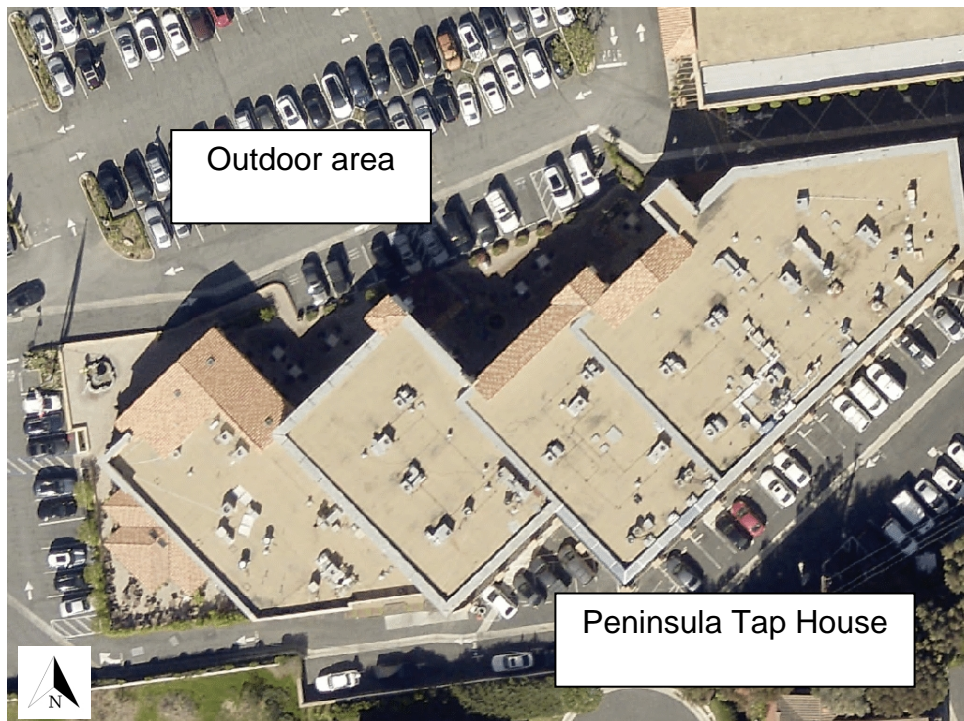

NOTICE IS HEREBY GIVEN that the Director of Community Development of the City of Rancho Palos Verdes will consider an application for the following project:

SPECIAL USE PERMIT (CASE NO. PLSU2022-0004) – A request by the Peninsula Tap House to conduct outdoor operations and entertainment at the Golden Cove Shopping Center as identified below:

- Amplified music performed by live musicians, three nights a week, up to a period of four months (November 2022 to February 2023) during the following days/times:
 - Wednesday- 5:00PM to 7:00PM
 - Saturday- 6:00PM to 8:00PM
 - Sunday- 3:00PM to 5:00P
- Proposed equipment includes speakers and an amplifier with a microphone for each member of the band. Instruments consist of guitars, base guitars, and drum sets.
- Set up and cleanup of area, 15 minutes before and after outdoor entertainment.
- Serving of beer, wine and food in coordination with the outdoor entertainment.
- Utilize an approximately 650 ft² patio area in front of the Peninsula Tap House for the outdoor operations and entertainment, as highlighted in the aerial map below:

Only those who have submitted written comments will receive notification of the decision. The Director's decision may then be appealed, in writing, to the Planning Commission.

If you would like the opportunity to review the application package and the proposed plans, they are on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review by appointment from 7:30 a.m. to 5:30 p.m. Monday through Thursday, and from 7:30 a.m. to 4:30 p.m. Friday.
