Remote participation by any Council Member shall be in accordance with Subdivisions (b)(3) or (f) of Government Code Section 54953. The meeting will be held at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and/or via teleconference for staff/consultants/participants using the Zoom platform and broadcast live on the City's website at [rpvca.gov/agendas](http://rpvca.gov/agendas) and on PVPTv channels Cox 35 and Frontier FiberOptic 39. PLCU2023-0004) & ADDENDUM NO. 50 ENVIRONMENTAL IMPACT REPORT NO. 36**— A request to revise Condition of Approval No. Z.14 of Conditional Use Permit No. 162 to allow the property at 31925 Emerald View Drive (Lot No. 34 of Tract No. 50667) to legalize after-the-fact grading and construction of improvements over an existing 2:1 slope along the rear and side yard areas of the project site. The City Council will also consider adoption of Addendum No. 50 to Environmental Impact Report No. 36 as part of the project's environmental assessment.
