## NOTICE

NOTICE IS HEREBY GIVEN that the Director of Community Development of the City of Rancho Palos Verdes will consider an application for the following project:

### **SITE PLAN REVIEW WITH NEIGHBORHOOD COMPATIBILITY (CASE NO. PLSR2022-0443)**

– A request for the following improvements to an existing single-family residence:

- Construction of a 1,119 ft<sup>2</sup> second-floor addition to an existing 5,998 ft<sup>2</sup> split-level residence for a new total structure size of 7,117 ft<sup>2</sup> (garage included);
- Demolition of an existing 196 ft<sup>2</sup> first-floor deck and construction of a new 685 ft<sup>2</sup> first-floor deck at the rear of the residence (west façade);
- Construction of new 102 ft<sup>2</sup> balcony area, consisting of a 51 ft<sup>2</sup> balcony at the west façade of the residence and a 51 ft<sup>2</sup> balcony at the east façade.
- Construction of a new 308 ft<sup>2</sup> first floor trellis at the south façade of the residence.
- The height of the proposed residence on the down sloping lot will be 12.6 feet, as measured from the average elevation of the setback line abutting the street of access (elev. 95.51 feet) to the highest proposed roof ridgeline (elev. 108.11 feet); and an overall height of 25.98 feet, as measured from the lowest finished grade adjacent to the structure (elev. 82.13 feet) to the highest proposed roof ridgeline (elev. 108.11 feet).

This project is categorically exempt pursuant to California Environmental Quality Act, Section 15301 (Existing Facilities).

Pursuant to the provisions of the Rancho Palos Verdes Municipal Code (RPVMC), no public hearing is required for this project. However, Section 17.02.030.B of the RPVMC requires a

finding of "Neighborhood Compatibility" for the proposed addition. In making such a finding, the City will review the proposed project relative to the following criteria for the immediate neighborhood: 1) scale of surrounding residences; 2) architectural style and materials; and 3) front, side, and rear yard setbacks.

The reason you are receiving this notice is because your property is located within 500 feet of the proposed project. Temporary frame structures (silhouettes) have been constructed on the project site outlining the height and bulk of the proposed project. These frames will be in place throughout the duration of the public comment period to better assist you and the City in assessing any potential project impacts.

If you have any comments or concerns about the proposed project, please communicate those thoughts in writing to Senior Planner, Amy Seeraty, by **4:30 pm on Friday, September 13, 2024**. By doing so, you will ensure that your comments are taken into consideration for the staff analysis of the project. Please note that written materials, including emails, submitted to the City are public records and may be posted on the City's website. Accordingly, you may wish to omit personal information from your written materials as it may become part of the public record. Only those who have submitted written comments will receive notification of the decision. The Director's decision may then be appealed, in writing, to the Planning Commission.

If you would like the opportunity to review the application package and the proposed plans, they are on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review by appointment from 7:30 a.m. to 5:30 p.m. Monday through Thursday, and from 7:30 a.m. to 4:30 p.m. Friday. **Please note that the City will be closed for the Labor Day Holiday on Monday, September 2, 2024.**
