NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on **Wednesday, November 4, 2009 (note the meeting date change)**, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, to consider:

TERRANEA RESORT AND SPA: ZON2009-00401 (REVISION 'M' TO COASTAL PERMIT NO. 166, CONDITIONAL USE PERMIT NO. 215, GRADING PERMIT NO. 2229, VARIANCE NO. 489, AND TENTATIVE PARCEL MAP NO. 26073): A request to amend the Council adopted Conditions of Approval by extending the condition compliance date for specific conditions from November 1, 2009 to January 4, 2010 or prior to the issuance of the Final Certificate of Occupancy for the main hotel building, whichever occurs first (it should be noted that the main hotel is currently operating under a Temporary Certificate of Occupancy issued by the City's Building Official).
