NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on **Tuesday, October 21, 2014**, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, to consider:

TERRANEA RESORT AND SPA: ZON2014-00388 (REVISION 'Q' TO COASTAL PERMIT NO. 166, CONDITIONAL USE PERMIT NO. 215, GRADING PERMIT NO. 2229, VARIANCE NO. 489, AND TENTATIVE PARCEL MAP NO. 26073): A request to amend the Council adopted Conditions of Approval to: 1) delete Condition No. 40 (c and d) that requires a 1% Transfer Fee be paid to the City upon each transfer of ownership of the on-site owned units, including, without limitation, the bungalow units, resort villas, casitas and fifty hotel guest suites or guestrooms and to establish a new nonprofit corporation with a seven-member board of directors to undertake the duties specified in this condition; 2) construct a new 9,400 square foot Golf and Landscape Maintenance Yard located off the lower public parking lot with approximately 150 cubic yards of earth movement to accommodate the paved pad area; 3) construct a new 1,675 square foot upper resort pool (including 9,500 square feet of deck area) and a 1,100 square foot ancillary pool building to accommodate the pool equipment, restrooms and poolbar at a height of 14-feet, as measured from finished grade and 500 square feet of pool cabanas. The upper pool is proposed to be located at the existing lawn area between the main hotel building and Mar'sel restaurant; and 4) construct a 350 square foot outdoor bar and seating area at a height of 12-feet, as measured from finished grade, located at the main pool area.
