APPEAL OF A DIRECTOR'S UNSUBSTANTIAL AMENDMENT (CASE

NO. ZON2011-00281): On January 27, 2016, the Community Development Director approved an "unsubstantial amendment" to P.C. Resolution No. 2013-04 for a request to construct a 4'-0" tall retaining wall within the front yard of the subject property. The appellant has filed the appeal expressing concerns with the structural integrity of the wall and the slope supported by the wall, and the contents on the plans submitted by the applicant from which the Director made the unsubstantial determination.
